This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

Over-the-counter (OTC) derivative. An OTC derivative is a bilateral agreement between you and ABN AMRO, whereby commitments depend on the performance of an underlying asset (foreign exchange rate). An OTC derivative is not tradable on a regulated exchange.

Term

The maturity date (expiration date) of the product will be agreed upon when entering into the FX Option contract, with the intention of holding the FX Option until the maturity date.

Objectives

Buying an FX Option means that you agree in advance with the Bank the rate (strike price) for which you can buy or sell a particular currency on a particular date.

A purchased FX Option gives you the right to buy ('Call Option') or sell ('Put Option') currency. You have no obligation to buy or sell the currency. If the market rate at the expiry time on the agreed date is more favourable than the strike price, it is unfavourable to use your right to buy or sell currency (exercise the FX Option). In this case it is more favourable to buy or sell currency at the market rate at that time. You pay the Bank a premium in advance for buying an FX Option.

The FX Option can be used for hedging or investment purposes.

The amounts and other details in this document are used for indicative purposes. The calculations assume a nominal amount of EUR 10,000.00, GBP/USD as the currency pair and a term of 1 month. These details probably differ from the ones in your agreement with ABN AMRO. The example is for illustrative purposes only.

Intended retail investor

This product is intended for retail investors who wish to hedge their foreign exchange rate risk or would like to use this product for investment purposes. This product is suitable for retail investors that have sufficient knowledge of and experience with this product, its performance and the risks associated with it.

To make sure you understand the performance of and risks associated with this product, please consult the information provided in the relevant product information document. This product is intended for retail investors that are willing and able to bear a total loss of their investment, and accept the credit risk of the issuer and have a minimum investment horizon consistent with the maturity date of the product.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 1 month. You may not be able to end your product easily or you may have to end at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions could impact the capacity of ABN AMRO to pay you. Be aware of currency risk. You will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. For legal reasons, no account is taken here of whether you actually need or will receive foreign currency. This product does not include any protection from future market performance so you could incur significant losses. If ABN AMRO is not able to pay you what is owed, you could incur significant losses.

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The scenarios shown illustrate how your investment could perform. How long should I hold it and can I take money out early?

The recommended holding period is the same as the term of the product.

Do you know before the agreed date that you will not be using your FX Option? Then you can terminate the FX Option early. This means that you sell the previously purchased FX Option back to the Bank.

Good to know: you won't get anything back from the advance premium. Nevertheless, the Bank will credit you with the "market value" of the FX Option at that time. The market value of the FX Option depends on the remaining term, the amount, the strike price, market rate and market rate volatility. There are two possibilities:

- The FX Option has a positive market value. The Bank will then pay you an amount.
- The FX Option has no market value. You do not receive or pay anything.

Please note: the FX Option may still gain in market value during the remaining term.
