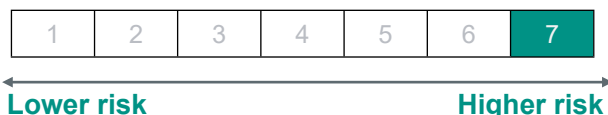
You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type	Over-the-counter (OTC) derivative. An OTC derivative is a bilateral agreement between you and ABN AMRO, whereby commitments depend on the performance of an underlying asset (foreign exchange rate). An OTC derivative is not tradable on a regulated exchange.
Term	The maturity date (expiration date) of the product will be agreed upon when entering into the FX Option contract, with the intention of holding the FX Option until the maturity date.
Objectives	<p>Selling ('writing') an FX Option means that you agree in advance with the Bank the rate (strike price) for which the Bank can buy ('Call Option') currency from you or sell ('Put Option') currency to you on a particular date.</p> <p>Selling ('writing') an FX Option gives the Bank the right to buy ('Call Option') currency from you or sell ('Put Option') currency to you. You have the obligation to buy ('Put Option') or sell ('Call Option') the currency. If the market rate at the expiry time on the agreed date is more favourable than the strike price, the Bank will not use its right to buy or sell currency (exercise the FX Option). You receive a premium in advance from the Bank for selling an FX Option.</p> <p>Selling ('writing') an FX Option can be used for investment purposes.</p> <p>The amounts and other details in this document are used for indicative purposes. The calculations assume a premium of EUR 10,000.00, EUR/USD as the currency pair and a term of 3 months. These details probably differ from the ones in your agreement with ABN AMRO. The example is for illustrative purposes only.</p>

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 3 months. **You may not be able to end your product easily or you may have to end at a price that significantly impacts on how much you get back.**

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions could impact the capacity of ABN AMRO to pay you. **Be aware of currency risk. You will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.** For legal reasons, no account is taken here of whether you actually need or will receive foreign currency. This product does not include any protection from future market performance so you could incur significant losses. If ABN AMRO is not able to pay you what is owed, you could incur significant losses.

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The scenarios shown illustrate how your investment could perform. Selling a Call Option holds that you think the underlying price (currency) on the expiry date will be below the strike price. If you terminate the product earlier than the recommended holding period, you will have to pay extra costs.

What happens if ABN AMRO is unable to pay out?

This product is not covered by any guarantee scheme. This means that in case the PRIIPs manufacturer is unable to pay out due to bankruptcy or an administrative measure of the competent authority, you could incur a significant loss.

What are the costs?

How long should I hold it and can I take money out early?

The recommended holding period is independent of the term of the product.

If you wish to buy the FX Option back from the Bank, the Bank calculates the current value of the FX Option. You have to pay this value to the Bank in order to buy back the FX Option. The market value of the FX Option depends on the remaining term, the amount, the strike price, market rate and market rate volatility. This value can be higher or lower than the premium received initially. This amount can be significant.

Please note: there is no maximum to your loss when selling a Call Option.
