Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

Over-the-counter (OTC) derivative. An OTC derivative is a bilateral agreement between you and ABN AMRO, whereby commitments depend on the performance of an underlying asset (foreign exchange rate). An OTC derivative is not tradable on a regulated exchange.

Term

The maturity date (expiration date) of the product will be agreed upon when entering into the Forward Extra contract, with the intention of holding the Forward Extra until the maturity date.

Objectives

An FX Forward transaction is a simple way to hedge a foreign exchange risk. With a Forward transaction, you agree with the Bank the rate at which you will buy or sell a certain deliverable currency on a particular date (the "forward rate"). This gives you certainty in advance on the rate of your foreign exchange transaction. With an FX Forward Extra, you agree with the Bank the exchange rate (the "protected rate") at which you can buy or sell a certain currency on an agreed date. In addition, you retain freedom up to a certain point (the "agreed barrier rate") to buy or sell the currency at the market rate when the exchange rate moves in your favour.

Please note: the protected rate of a Forward Extra is less favourable than the forward rate of a Forward transaction with the similar characteristics. If the market rate on the agreed date is less favourable than your protected rate you buy or sell the currency against the protected rate. When the market rate on the agreed date is between your protected rate and the barrier rate, you can buy or sell the currency at the favourable market rate. However, if the market rate equals or exceeds the barrier rate during the term of the contract, you must buy or sell the currency at the protected rate, this is a less favourable rate than the market rate. With a **European** Forward Extra, ABN AMRO only checks on the expiry date whether the barrier rate has been reached or exceeded. But you can also agree that the Bank looks at whether the barrier rate is reached or broken during a certain period. This is the **Window** Forward Extra. The structure of a Forward Extra consists of three FX Options:

- One FX Option that you buy from the Bank and that gives you the right to buy or sell the currency at the
 protected rate,
- 2. One FX Option that you sell to the Bank and that obliges you to buy or sell the currency at the protected rate,
- 3. One FX Option that you buy from the Bank. This FX Option ensures that ABN AMRO can only start using the FX Option that you sold once the barrier rate has been reached or exceeded.

The protected rate and barrier rate are chosen in such a way that you do not pay or receive a premium. The FX Forward Extra can be used for hedging or investment purposes.

The amounts and other details in this document are used for indicative purposes. The calculations assume a nominal amount of EUR 10,000.00, EUR/GBP as the currency pair and a term of 6 months. These details probably differ from the ones in your agreement with ABN AMRO. The example is for illustrative purposes only.

Intended retail investor

This product is intended for retail investors who wish to hedge their foreign exchange rate risk or would like to use this product for investment purposes. This product is suitable for retail investors that have sufficient knowledge of and experience with this product, its performance and the risks associated with it.

To make sure you understand the performance of and risks associated with this product, please consult the information provided in the relevant product information document. This product is intended for retail investors that are willing and able to bear losses greater than their investment, and accept the credit risk of the issuer and have a minimum investment horizon consistent with the maturity date of the product.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 6 months. You may not be able to end your product easily or you may have to end at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions could impact the capacity of ABN AMRO to pay you. Be aware of currency risk. You will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. For legal reasons, no account is taken here of whether you actually need or will receive foreign currency. This product does not include any protection from future market performance so you could incur significant losses. If ABN AMRO is not able to pay you what is owed, you could incur significant losses.

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The scenarios shown illustrate how your investment could perform. What happens if ABN AMRO is unable to pay out?

This product is not covered by any guarantee scheme. This means that in case the PRIIPs manufacturer is unable to pay out due to bankruptcy or an administrative measure of the competent authority, you could incur a significant loss.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- You would get back the amount that you invested (0 % annual return).

How long should I hold it and can I take money out early?

The recommended holding period is the same as the term of the product.

If you know before the agreed date that you will not be using your Forward Extra, you can unwind the contract, ABN AMRO will settle the market value with you. The Bank calculates the current value of the contract. The value depends on the agreed rates, the remaining maturity and the volatility of the currency pair. There are two options:

- The FX Forward Extra has a positive market value. You then receive an amount from the Bank.
- The FX Forward Extra has a negative market value. You then have to pay an amount to the Bank.

Unwinding your Forward Extra can therefore be profitable but can also result in significant losses for you.

When you unwind the Forward Extra transaction as set out above, you will be entering into a new product and this may include costs (see the section "What are the costs?").
